# Rules & Regulations for Royalton Lions 2010 Bass Tournament

## I PARTICIPANTS AND ELIGIBILITY

- A. Contestant must enter as two-man teams. Any person under 16 years old must be teamed with their parent or legal guardian.
- B. Each entrant must have in his or her possession a valid fishing License from the State of Minnesota.
- C. The Lions Club Tournament Officials, Sponsors or any person responsible for tournament operations and their Corporation, Companies, agencies and agents are not to be held responsible for death, injury, damage, theft, fire, or any loss. Entrants shall sign a waiver as part of their registration.

## II SAFETY

- A. All boats must meet U.S. Coast Guard safety regulations as well as those of the State of Minnesota. Safe boating conduct and all safety precautions must be observed at all times.
- B. Each entrant will be required to have a U.S. Coast Guard approved personal flotation device (PFD). It must be worn and fastened when the engine is operating above trolling speed. No alcoholic beverages are allowed during tournament hours. Drunkenness by any competitor during the tournament hours will not be tolerated and shall be cause for disqualification.
- C. Contestants may not leave their boats during tournament hours, except in the event of sickness or brief excursions for "nature calling", severe storm or other such hazard. If for any reason a team decides to leave the tournament waters early, both members shall bear full responsibility for notifying a tournament official. In case of a breakdown, one partner may return with fish by another tournament boat while the other partner is permitted to stay with the disabled boat.
- C. Breaking any state or federal law will be grounds for disqualification.

## III TACKLE AND FISHING METHODS(Landing nets allowed)

- A. **Artificial Lures Only.** All fish must be caught live and in a conventional sporting manner on hook and line. No snagging. All fishing must be done from a tournament inspected boat.
- B. Each contestant will be allowed a maximum of one line in the water at any time. Spare rods and equipment may be carried in the boat.
- C. CB or marine radios are allowed for emergency use only. Transmitting information on a radio concerning any aspect of the taking of fish during the tournament is prohibited.
- D. Only live and/or apparently fresh fish will qualify for tournament weigh-in. Judgment by the officials is final. All fish weighed must be kept and carried in aerated live wells or aerated cooler system. The use of fish stringers, wire baskets, boat bags, or other means of keeping fish is prohibited.
- E. **All culling must be done on the water;** no team may have more than the tournament limit in the livewell at any time during the tournament. Fish released by individual anglers must be capable of holding themselves in the water and have a high probability of survival.
- F. Only Small and Large Mouth bass will be allowed in possession.
- G. No fishing spot can be held by a competitor or other angler for a competitor.

## IV PERMITTED FISHING WATERS

- A. Fishing will be permitted on the Mississippi River from the Blanchard Dam north to the Little Falls Dam.
- B. Blanchard Dam Landing will serve as tournament headquarters.
- C. The Swan River will be closed as tournament water.
- D. Tournament sponsored boats are prohibited from entering stands of Eurasian watermilfoil marked with yellow bouys.
- E. **The waters from the mouth of the Swan River, north to Little Falls Begin to shallow rapidly. Proceed with caution and at your own risk.**

## V FISHING HOURS

- A. Tournament hours will be from 7:00 to 3:00 p.m., August 21, 2010.
- B. Boats must be available for pre-start inspection as shown on weigh-in slip.

- C. All tournament watercraft and trailers will be inspected in and out before launching into and upon leaving the waters for the presence of Eurasian watermilfoil, other plant species and other exotics including zebra mussels. All bilges and live wells must be drained, and boats and trailers made free of all vegetative matter and exotic species. Vegetative matter and exotic species must be disposed of at locations where they cannot enter any public water. Tournament weigh-in slips must be validated before being allowed to leave in the flight.
- D. A drawing will be held on May 30, 2010 for registrations received through that date. Boat placement will be randomly drawn at that time. Registrations received after May 30, 2010 will be placed in the order in which they are received. **The tournament field will be divided into separate flights. Pre-flight staging areas will be assigned at check-in.** Boats will be released by number. Official time will be announced during pre-flight inspections.
- E. Contestants who return later than the assigned flight times or who leave at an earlier flight time will be disqualified. No exceptions and no excuses.

## VI SCORING (12" minimum Fish Length)

- A. The team weight will be the total weight of a maximum of **Five (5) fish per boat.** Small/Large mouth bass only will count. Weigh-in will be on a first come first serve basis. Once fish have been presented to a Tournament Official to be weighed-in all fish become the property of the Royalton Lions and no additional fish may be brought to the scales. Bags will be limited in order to avoid a bottleneck at the weigh-in tanks. Teams not weighing any fish are still required to check in with tournament officials in order to account for all teams.
- B. Any fish mauled, mashed, frozen, stringered, injected with water or other fluids containing foreign matter to add weight or showing extreme loss of gill color may result in a disqualification at the discretion of the tournament director or weigh-in official.
- C. Winning teams will be determined by total team weight for the day of fishing. In the event of a tie, the purse for the two places will be added and each team will receive 50% of this amount.
- D. This tournament is a Catch & Release Tournament. Any fish brought in deemed not returnable will be penalized eight ounces (1/2 pound) per dead fish.
- F. Fish under 12" will be penalized eight ounces (1/2 pound) and will not weigh.

## VII PROTESTS

- A. Tournament Committee, or any contestant, has a right to protest another team or contestant. The protest must be filed in writing with the Tournament Director no later than one hour after the close of the tournament fishing hours. A three (3) man protest committee shall be appointed by the Tournament Committee prior to the tournament and will convene to hear both sides of any protest. The decision of the protest committee shall be final in all cases. A \$50 protest fee must accompany each written protest. The fee will be returned if the protest is found valid. If the protest is valid, disqualified party must pay all investigative costs. If the protest is invalid the fee will not be returned.

## VIII MISCELLANEOUS

- A. All questions or problems connected with the rules of this tournament are to be referred to the tournament directors. All decisions of the tournament director shall be final.
- B. Contestants are not permitted to fish within (60) feet of Another competitor's boat at any time. In the interest of good sportsmanship, competitors will not crowd or impede each other. No two (2) contestant's boats may pull up to each other during tournament hours.
- C. Patrol and safety boats may pull up and inspect contestants at any time. Anyone found cheating will be immediately disqualified and the reasons for that disqualification announced at the weigh-in.
- D. All teams are subject to polygraph test and/or voice stress tests prior to distribution of awards. Determination of polygraph and/or voice stress tests are final and binding for all parties.
- E. Disqualification for any reason will result in forfeiture of entry fee.
- F. All rules have "loopholes." It is the intention of the sponsors to provide an honest sportsman like tournament. In the interest of good sportsmanship, contestants are reminded that the "spirit of the rule" will prevail in all judgment cases.
